On the solution of the tasks facing the audit service in a pandemic

In order to reduce the negative impact of economic uncertainty on the quality and quantity of audits of financial statements in the context of a global pandemic around the world and to ensure the support of an independent audit for the sustainable development of the country's economy in the current complex environment,

I decide:

1. To establish the Working Staff in the following structure in order to ensure the identification of problems facing independent audit in the country in modern conditions, development of recommendations in accordance with the challenges of the new era for the prompt and effective solution of these problems, providing practical assistance to members of the Chamber of Auditors, immediate study and resolution of proposals and recommendations received from members of the Chamber, if necessary, raising before the relevant central executive authorities, application of advanced foreign experience in the audit of Azerbaijan during the pandemic:

5. To instruct the Audit Organization, Accountability and Information Department (V.Javadov) to ensure sending of the text of this order to audit organizations and independent auditors.

6. To provide placement of the text of this order on the website of the Chamber.
